



INSURANT MEMO

PJSC "Insurance Company "Illichivske"

Dear participant!

Insurance company "Illichivske" informs you that you are insured based on the Contract of voluntary accident insurance and are eligible for insurance payments upon the occurrence of the appropriate insured accidents during the marathon.

The insured accident is an event that occurred during the marathon:

- traumatic or other injury;
- acute health disorder and bodily dysfunction, including those resulting from heat and sunstroke;
- permanent disability (establishment of disability groups 1 and 2) as a result of an accident;
- death as a result of an accident.

Thus, the term "accident" means random, sudden, short-term, unpredictable, not caused deliberately and independent from the will of the Insured Person (IP) event that occurred during the marathon due to external factors.

In case of health problems you should immediately contact the emergency doctor (that must be present during the marathon) for immediate medical care.

Then notify the Department of Medical Assistance of IC "Illichivske" of the insured accident, call the multichannel phone numbers:

When contacting the Department of Medical Assistance, please provide the coordinator with the following information:

- your first and last name;
- the cause and nature of the insured accident;
- location and time of the insured accident.

Please, notice! **The accident, which occurred during the marathon, but was not confirmed by a medical conclusion from the emergency doctor that was present during the marathon, is not considered to be an insured accident.**

Also, during the marathon there will be a representative of PJSC "IC "Illichivske" at the marathon village in the area of the start-finish line, who will provide the necessary support in the event of the insured accident ([consultation on conditions of insurance payments and further action of the IP for such payments due to an insured accident](#)).

In order to receive insurance payment, you should submit the following documents to the IC "Illichivske":

- application for insurance payment;
- documents that allow identification of the person Insuring/IP/beneficiary and TIN;
- medical conclusion from the emergency doctor;
- the application for insurance payment should include the following documents depending on the nature of the accident:
 - sick leave (if any);
 - abstract of epicrisis from the medical record of the patient/outpatient;
 - document from the competent authorities, confirming the fact of the accident;
 - certificate of medical social expert commission (MSEC) on disability;
 - certificate from the medical advisory committee on the establishment of category "disabled child";
 - 106/0 form (medical certificate of death of IP);
 - document certifying inheritance;
 - other documents at the request of the Insurer regarding the fact, reasons, circumstances of the event that has features of an insured accident.

Insurance payment is made within the insured sum of 30,000 UAH. The amount of insurance payment depends on the consequences of the accident provided in the contract as follows:

- traumatic injuries - the insurance payment is calculated according to the table "List of traumatic injuries and the amount of payments";
- disability group 1 - 100%;
- disability group 2 - 80%;
- death - 100%.
